**ORDER:**

In the G.O. first read above, notification was issued specifying the Special Sessions Courts for trial of cases under SCs & STs (POA) Act, 1989" in the Districts and the Metropolitan Sessions Judges Courts in Hyderabad and Cyberabad as Special Courts under section 84 of the Rights of Persons with Disabilities Act, 2016.

2. In the letter 2<sup>nd</sup> read above, the Director of Prosecutions (FAC), Telangana State, Hyderabad, has stated that upon issuing notification specifying the Special Sessions Courts in each district, the concerned Public Prosecutor can be designated as Special Public Prosecutor for the purpose of conducting cases in that Courts under Section 85 of the Rights of Persons with Disabilities Act, 2016.

Government, after careful examination of the matter, have decided to designate the Public Prosecutors in the Special Sessions Courts for trial of cases under SCs & STs (POA) Act, 1989 in the Districts and the Metropolitan Sessions Judge, Hyderabad and the I Additional District & Sessions Judge-cum-Metropolitan Sessions Judge, Cyberabad at L.B.Nagar as Special Public Prosecutors for the purpose of conducting the cases in the said Courts.

4. Accordingly, the following Notification will be published in an Extra-ordinary issue of Telangana Gazette, dated:01-10-2020.

In exercise of the powers conferred by Sub-section (1) of Section 85 of the Rights of Persons with Disabilities Act, 2016 (Central Act No.49 of 2016), the Government of Telangana, hereby designate the Public Prosecutors in the Special Sessions Courts for trial of cases under SCs & STs (POA) Act, 1989 in the Districts and the Metropolitan Sessions Judge, Hyderabad and the I Additional District & Sessions Judge-cum-Metropolitan Sessions Judge, Cyberabad at L.B.Nagar as Special Public Prosecutors to conduct prosecution in the trial of offences filed under the Rights of Persons with Disabilities Act, 2016 (Central Act No.49 of 2016).
