As per Section 33 of the Rights of Persons with Disabilities Act, 2016 "The appropriate Government shall;

- (i) identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34;
- (ii) constitute an expert committee with representation of persons with benchmark disabilities for identification of such posts; and
- (iii) undertake periodic review of the identified posts at an interval not exceeding three years.
- 2. As per Section 34 (1) of the Rights of Persons with Disabilities Act, 2016 "Every appropriate Government shall appoint in every Government establishment, not less than four percent of the total number of vacancies in the cadre strength in each group of posts meant to be filled with persons with benchmark disabilities of which, one percent each shall be reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one percent for persons with benchmark disabilities under clauses (d) and (e), namely:—
 - (a) Blindness and low vision;
 - (b) Deaf and hard of hearing;
 - (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
 - (d) Autism, intellectual disability, specific learning disability and mental illness;
 - (e) Multiple disabilities from amongst persons under clauses (a) to(d) including deaf-blindness in the posts identified for each disabilities:

- In the references 2 to 4 read above, orders were issued specifying the posts which can be reserved for the persons with disabilities for the categories of Group IV, I and II in Direct Recruitment vide Labour WDCW G.O.Ms.No.145, (WH.DESK) & Department, dt.28.09.1992 and G.O.Rt.No.297, WDCW & DW Department, WDCW dt.9.10.2006 and G.O.Rt.No.106, & DW Department, dt.13.4.2007 respectively. The above orders are to be revised as per the Rights of Persons with Disabilities Act, 2016.
- 4. In the reference 6th read above, the Director, Welfare of Disabled and Senior Citizens, Hyderabad have sent the proposals to the Government to constitute an Expert Committee for identification of posts as per Section 33 (ii) Rights of Persons with Disabilities Act, 2016.
- 5. Government after careful examination of the matter, hereby constitute an expert Committee as per Section 33 (ii) Rights of Persons with Disabilities Act, 2016 with the following members for identification of posts and to submit a list of posts which can be reserved for the differently abled persons with benchmarks disability as mentioned in Section 34 of Rights of Persons with Disabilities Act, 2016.
