The Court of the State Commissioner has called for an ATR from the Director of Public Health & Family welfare, Government of Telangana vide reference 2nd cited on the complaint filed by Development Society for the Deaf, represented by its President of its State Committee. It is requested that to fill up the vacancies of MPHA posts by the candidates belongs to HH

(General), if VH (W) and HH (W) candidates not avail able as per SRD held in 2017 or in the subsequent years in the light of relevant Departmental Rules and G.O.Ms. No.6 dated 20-07-2018 of WCD & SC Department.

The Court of the State Commissioner for RPwDs vide reference 2nd and 3rd cited has desired to conduct an enquiry and asked to furnish an Action Taken Report within 30 days to the State Commissioner, but it appears that no action was taken on the above complaint and no ATR is received in this office even after (2) reminders issued by this Court.

Hence, this Notice is issued to the Director of Public Health & Family welfare, Government of Telangana to furnish Action Taken Report on the above complaint within (30) days after receipt of this Notice. Non-compliance on the matter will be amounting to violation of Section 93 of RPwD Act, 2016 and further action will be initiated as per the Act by the Court of the State Commissioner, as the State Commissioner itself is a Civil Court vested with the Civil Judicial Powers under Section 82 of the RPwD Act, 2016.
