I am to inform that a news item was telecasted on 07-04-2021 in  
Adab Hyderabad Youtube News Channel, in which it was brought into the  
light that one Visually Impaired person named Nagarani, R/o. Bingidoddi  
(V), Aiza (M) her disabled pension was removed by officials by showing the  
status of the person is no more. But the above named person is alive as on  
date and she is the recipient of National and State level awards as per the  
news item.

**The State Commissioner has taken it as Suo-Moto to register the  
case for the above lapse by the officials concerned.**

The above violation attracts Section 24 of RPwD Act, 2016 which provides social security to the disabled.

You are therefore required to enquiry into the matter in consultation with concerned and initiate immediate action on the concerned and take necessary action for restoration of discontinued pension to the above disabled person and arrange to send an Action Taken Report within (7) days to the State Commissioner, RPwDs, failing which it attracts the provisions of Section 24 & 93 RPwD Act (Rights of Persons with Disabilities Act), 2016.
