Sri Daram Damodar, /o. Ravulapally, Thungathurthi (M) submitted a petition before the Court of the State Commissioner, RPwDs requesting to arrange to issue Darani Pass Book from the MRO, Thungathurthi (M) for his own land admeasuring 0.35 guntas. He further stated that the tenants by name Sri Chilukuri Venkanna and his father Sattaiah who are cultivating the land for the last two years have not paid the lease amount to him and trying to grab the land by creating false papers. He further informed that he met MRO, Thungathurthi, RDO, DRO and Joint Collector several times for issuing Dharani Pass Book, but there is no response from them for the past two years.

The Collector & District Magistrate, Suryapet was required by this office to examine the contents raised by the petitioner and to arrange to issue required land documents from the MRO, Thungathurthi, besides providing protection to his land and an Action Taken Report was called for vide this office Lr. No. RPwD Act/LC/126/2019 dated 13-08-2018. But even after lapse of the stipulated time, no report is received.

Hence, this Notice issued to the Collector & District magistrate, Suryapet District and Tahsildar, Thungathurthi calling for an Action Taken Report on the above matter to be received within a period of (30) days from the date of receipt of this Notice.

Non-furnishing of required information will lead to imposition of penalty under Section-93 of RPwD Act, 2016 which reads as follows:

Section 93: Punishment for failure to furnish information:

“Whoever, fails to produce any book, account or other documents or to furnish any statement, information or particulars which, under this Act or any order, or direction made or given thereunder, is duty bound to produce or furnish or to answer any question put in pursuance of the provisions of this Act or of any order, or direction made or given thereunder, shall be punishable with fine which may extend to twenty-five thousand rupees in respect of each offence, and in case of continued failure or refusal, with further fine which may extend to one thousand rupees for each day, of continued failure or refusal after the date of original order imposing punishment of fine.”
