On receipt of complaints from certain Associations representing the interests of Persons with Disabilities (PwDs) a letter dated 19.07.2018, has been addressed to the DEO, Nalgonda by this office by communicating a copy to the Collector & Dist. Magistrate, Nalgonda with directions to keep in abeyance, the selection in respect of all the posts of Spl. Officers, CRTs etc., in Kasthurba Gandhi Balika Vidyalaya, reserved for the disabled, since violation of G.O.No.99 of General Administrations (Services-D) Department, dated 04.03.2013 and Section 34 of the RPwD Act, 2016 has been alleged by the complainants. The respondent DEO and Collector & District Magistrate, Nalgonda have been called upon to furnish an Action Taken Report (ATR) in this regard immediately.

The State Project Director, SSA was required in this office letter dated 25.07.2018, to issue necessary instructions to all the DEOs in the State to comply with Section 34 of the RPwD Act and all the relevant G. Os referred to in the above letter, having a bearing on the subject, duly furnishing a compliance report to this office in this regard.

However, no such reports have been received in this office from the respondents so far, i.e., even after 30 days. This constitutes a serious lapse on the part of the DEO/Collector and the State Project Director, SSA.

Now, therefore, the respondents are hereby directed to show cause as to why the complaint should not be allowed. A detailed report shall be filed by the respondents within two weeks from the date of receipt of this Notice failing which orders deemed fit as per the relevant provisions of the Act shall be passed. It shall be construed that the respondents have nothing to say and the matter shall be disposed off, based on merits as per records. Violation of the said G.O. and Section 34 of RPwD Act, 2016 shall attract Section 89 & 93 of the said Act.
