The State Commissioner, RPwD Act, 2016 intend to bring the above correspondence to the notice of the Collector & District Magistrate. Brief facts of the petition are: that Sri Mohd. Shaik Khadar, R/o. Karimnagar has submitted a petition to the Court of the State Commissioner, RPwD Act, 2016, for conducting a detailed enquiry into the whole process of allotment of shutters available with Indian Red Cross Society and expressed that some shutters are under illegal custody and requested to allot one shutter to him keeping in view of his disability as per rules by calling fresh notification for allotment of vacant shutter. The petitioner also further stated that he has

met with discrimination due to his disability at the Indian Red Cross Society, Karimnagar.

The Collector & District Magistrate was asked to conduct detailed enquiry into the matter and explore the possibility of allotment of shutter belonging to IRC to the petitioner who is also a PwD and to furnish Action Taken Report to the State Commissioner within (3) weeks vide reference 3<sup>rd</sup> cited. But No ATR is received in the matter so far from the Collector & District Magistrate except a copy of the Proc. No. H3/1778/2017 dated 22-12-2018 and Proc. No. H5/1698/2018, dated 22-12-2018, issued in the name of Collector & District Magistrate, Karimnagar signed by the DRO, marked to the Director & State Commissioner for PwDs, Hyderabad.

The contents of the proceedings are inconclusive and did not cover the request of the petitioner and when the State Commissioner asked for an ATR marking a copy of incomplete proceedings leads to violation of provisions of RPwD Act, 2016.

It is felt necessary to bring it to your notice that as per Section 82 of RPwD Act, 2016, every Proceeding before the State Commissioner shall be a judicial proceedings within the meaning of Section 193 and 228 of the IPC (45 of 1860) and the State Commissioner shall be deemed to be a Civil Court for the purpose of Section 195 and Chapter XXVI of the Code of Criminal Procedure, 1973 (2 of 1974).

In the absence of required justice to the petitioner, he again filed another petition seeking detailed action on the matter.

Copy of the Petition is herewith sent for taking detailed enquiry in the matter and to take appropriate action and send the Action Taken Report to the Court of State Commissioner within (15) days after receipt of this Notice.

If the ATR is not received within (15) days further cause of action will be initiated as per RPwD Act & Rules without further intimation.
