SHOW-CAUSE NOTICE

On receipt of a petition from the petitioner in the Court of the State Commissioner on 2-1-2020 requesting for allotment of permanent light duties since the bus in which he was performing duties as a Conductor met with an accident on 16-7-2012 and he received spinal cord injuries to the extent of 55% of disability, Notices were issued on 24-1-2020 to the respondent Depot Manager and the M.D., TSRTC to examine the complaint and submit an ATR to this Court within 30 days.

As seen from the reply Depot Manager, it is observed that there is no mention of any action on the request of the petitioner. The petitioner being the conductor is requesting for allotment of light duties. So, the Respondent (Depo Manager) shall furnish the Action Taken Report on the petition filed by Sri M. Prasad, Conductor.

This Court brings to the notice of the Respondents that as per Section 82 of the RPwD Act, 2016 every proceeding before the State Commissioner shall be a judicial proceeding within the meaning of Section 193 and 228 of the IPC (45 of 1860) and the State Commissioner shall be deemed to be a Civil Court for the purposes of Section 195 and Chapter XXVI of the Code of Criminal Procedure 1973 (2 of 1974)

Inaction of the respondents in the matter that came up before the Court of the State Commissioner will attract the provisions of Section 89 and 93 of RPwD Act, 2016.

Now, therefore, the Respondent Depot Manager and the Managing Director, TSRTC are hereby called upon to show cause as to why the complaint should not be allowed. A detailed Action Taken Report (ATR) shall be filed by the Respondents within 15 days from the date of receipt of this Show Cause Notice failing which orders deemed fit as per the relevant provisions of the RPwD Act, 2016 shall be passed by this Court. It shall be construed that the respondents have nothing to say and the matter shall be disposed off based on merits as per records.

Failure to furnish ATR will attract Section 93 of RPwD Act, 2016
